We feel strongly that in-person learning is important for students in all divisions, and are committed to providing in-person education as much as possible. To facilitate in-person learning, we all must work together for the health and wellness of our community. We truly are in this together.

Though it is impossible to eliminate risks, Episcopal School of Baton Rouge has established measures to mitigate the risk of COVID-19 in accordance with guidelines outlined by CDC, AAP, LDH, LHSAA and the Episcopal Diocese of Louisiana. We invite you to partner with us in our efforts to facilitate healthy learning by committing to the Health and Wellness Pledge.

Monitor, Care and Prevention

Parental Commitment

- **Daily Home Health Screening** — I agree that, every day, before transporting my child(ren) to school, I will carefully examine or assess my child(ren) for any sign of COVID-19, including the following:
 - Elevated temperature of 100.4 F or higher, cough, sore throat, shortness of breath or difficulty breathing, chills, shivering, or sweating, new loss of taste or smell, vomiting/diarrhea. For a full list of COVID-19 symptoms, please visit the [CDC's website](#).
- **When to Stay Home**
 - If any sign of COVID-19 is present, I will not transport my child to school, and I will inform the school nurse and/or the division representative immediately.
 - I will keep my child home if I know that they have been in close proximity to someone who has tested positive for COVID-19. I will follow Episcopal's protocols for isolation or quarantine and will only return to school once a physician has approved.
 - If any sign of other illnesses such as seasonal flu is present, I will not transport my child to school.
- **School Screenings** - I understand that my child(ren)'s temperature may be taken each morning, and if that temperature is 100.4 F or higher, my child(ren) and any other passengers will not be allowed to attend school that day.
- **Face Coverings** - I understand that my child(ren) may be required to wear a face covering during their time at school, and I will supply my child(ren) with a covering. The school will have coverings available if needed.

Student Commitment

- **Face Covering** - I will adhere to the guidelines for wearing a face covering while on school grounds and agree not to share my face covering with other students.
- **Hand Hygiene and Respiratory Etiquette** - I will practice proper hand washing and respiratory etiquette (e.g., cover my cough).
- **Social Gatherings** - Recognizing that some people without symptoms may be able to spread the virus, and in accordance with state and federal guidelines, I will avoid crowded places and mass gatherings on and off campus. I will practice physical distancing when meeting in smaller groups and will wear my face covering.
- **Travel** - I will comply with the non-essential travel restrictions published by the CDC. I recognize that travel may result in a fourteen day self-quarantine.
- **Physical Distancing** - I will take daily precautions to keep space between myself and others (3 to 6 feet of physical distancing, which is about two arm lengths).
- **Observing Space Restrictions** - Episcopal has established guidelines for the use of campus buildings and the flow of foot traffic. I will adhere to the guidelines for the use of campus spaces.
